WHEREAS, the lowest responsible bidder is Green Valley Group, Inc. in the amount of \$73,700.00; and

WHEREAS, Township Engineer Cory Stoner reviewed and recommended the award to Green Valley Group, Inc. in the amount of \$73,700; and

WHEREAS, funds are available in Open Space Trust Fund; and


NOW, THEREFORE BE IT RESOLVED by the Mayor and Township Council, County of Sussex, State of New Jersey to award the bid to Green Valley Group, Inc. in the amount not to exceed \$73,700.00. Certification of funds has been provided. The Mayor, Township Manager and Clerk are hereby authorized to sign any document associated with this award.

**AUTHORIZATION TO EXECUTE CHANGE ORDER NO. 1
FOR PROPOSED BASKETBALL COURT REHABILITATION AT CARL O.
JOHNSON PARK**

WHEREAS, the Township of Byram (Owner) and Green Valley Group, Inc. entered into a contract for a proposed basketball court rehabilitation at Carl O. Johnson Park for a total of \$73,700 as stated in Resolution 162-2023; and

WHEREAS, in the process of completing the work, certain changes were authorized by the owner as detailed in Change Order No. 1; and

WHEREAS, the revised work was negotiated between the engineer Harold Pellow & Associates and the Contractor and was found to require a net increase of \$10,640.00.

NOW, THEREFORE, BE IT RESOLVED by the Township of Byram in the County of Sussex, State of New Jersey to authorize the Mayor to execute Change Order No. 1 resulting in a net increase of \$10,640.00 resulting in an adjusted contract price of \$84,340.00.
